# Marine Insurance & Claims

---

Both Frederick University and DNV GL firmly believe in the continuous development of specialized skills in the maritime industry and as such are committed to offering short courses for Professional Training, designed to meet the need for skilled labor in the most demanding and rapidly changing areas of the shipping industry.

The primary objective of the proposed seminar is to increase the awareness in Cyprus' marine insurance sector of the current issues and concerns impacting the marine sector and foreign insurance markets.

Since insurance and issues extend to maritime pollution (including marine accidents and pollution incidents), civil liability, etc. and are being further extended by key developments in the field of personal data (GDPR) and more; this seminar is a necessary first step in informing and upgrading the Cyprus insurance market.

Participants will be provided with supporting material during the training. Upon satisfactory course completion, participants will receive a Certificate of Attendance issued jointly by DNV GL and Frederick University. The seminar has been approved by the Human Resources Development Authority of Cyprus (HRDA) which subsidises 76% of the participation cost.

### SYLLABUS

Frederick University, in collaboration with the Classification Society Det Norske Veritas – Germanischer Lloyd (DNV GL), introduce a Professional Training course Marine Insurance & Claims, the syllabus comprises of the following subjects:

- Background to Marine Insurance
- Legal and practical aspects of the marine insurance covers, including Hull and Machinery, P&I, FDD, war risks and charterers liabilities. Extensions to War Risks insurance (K&R – C.E.N.D.).
- GDPR – key changes on processing personal data
- Navigation limits
- Cyber security risks
- Marine claims: collision, GA, salvage, wreck removal, marine pollution, cargo claims and oil pollution
- Places of refuge and maritime refugees
- Enforcement of claims
- Charter party disputes including bunker disputes
- Crew, passenger, shore workers and stowaways' claims

### PROGRAMME SUPPORT

Participants will have access to the necessary facilities of Frederick University as well as access to supporting material, all of which is included in the course fee. Upon satisfactory course completion, including a test, participants will receive a Certificate issued jointly by DNV GL and Frederick University.

### **Patrick Donner, PhD (LLM)**

Patrick Donner, AFNI, received an LLM from the University of Turku and, having qualified for the judiciary, served on the bench for five years. He worked for 14 years in executive positions in shipping companies in Finland (tankers, ferries and cruise) after which he had his own law and management consultancy firm for a few years. During all this time he taught maritime law (part-time) at the Maritime Academy of Åland and also held numerous non-executive positions on boards of directors of shipping and insurance companies as well as elected public office at local level. Patrick Donner joined the World Maritime University (WMU) as Associate Professor in Shipping Management in 1995 and served as Associate Academic Dean from 2006 until February 2017. Mr. Donner was also Programme Co-ordinator of the Postgraduate Diploma course (by distance learning) in Marine Insurance (2005-2018) and continues to lecture in WMU's MSc programme in International Transport and Logistics at Shanghai Maritime University. In 2018 WMU awarded him the title of Honorary Professor. He is a visiting Associate Professor in the Maritime MSc and MA/LLM programmes of Frederick University in Cyprus.



### **Nicholas G. Berketis, PhD (Actuarial Science)**

Nicholas G. Berketis is Manager of J. Kouroutis & Co. Ltd. Insurance and Reinsurance Brokers, Piraeus, Greece and Visiting Lecturer at Frederick University, Cyprus. He holds a PhD in Actuarial Science and MSc in Shipping, Trade & Finance from Sir John Cass Business School, The City University, London, UK, and BSc (Hons.) in Economics from the University of Athens. He is a member of the Economic Chamber of Greece, the Piraeus' Professionals Chamber and the US Propeller Club, port of Piraeus. His research area is Marine Insurance with emphasis in areas of Piracy, Fishing Vessels, Ferries, etc. This research has been presented in professional and academic conferences and published in journals and the press.
